Greg moved to Orange County in 1978 as a young First Lieutenant in the United States Marine Corps. During the 30 years that he served as a Marine officer and fighter pilot, he became a decorated combat veteran of Desert Storm and went on to command several aircraft units post war, including Commanding Officer of Marine Aircraft Group 46 at the Marine Corps Air Station Miramar in San Diego. At the time, it was the largest composite air group in the Marine Corps, with over 1,000 personnel and 70 aircraft. During the tragedies of 9/11, Greg was part of the military air support leadership responsible for protecting southern California, to defend against potential further attacks against our homeland.
